**ELECTION NOTICE**

It is hereby notified that a General Election of Members of the West Bengal Medical Council **under clauses (g) & (h) of Section 4(1)** of the Bengal Medical Act, 1914 as amended from time to time and by the Bengal Medical (Amendment) Act, 1989 (West Bengal Act XXVI of 1989), will shortly be held and that for this purpose the Returning Officer has under rule 5(1)(a) of the Election Rules made by the Government (published with Government Notification No.H/MA/400/5M-1/88/Part 1 dated 20<sup>th</sup> February, 1991 in the Calcutta Gazette Extra-Ordinary of February 20, 1991) **appointed 31<sup>st</sup> January, 2018** as the date up to which the names and other requisite particulars of the persons entitled to vote at the election have been entered on the Draft Electoral Roll.

The Draft Electoral Roll under clauses (g) & (h) would be kept open for public inspection under rule 5(3) of the Election Rules in the office of the Returning Officer at IB - 196, sector - III, Salt Lake, Kolkata - 700 106 **from 7<sup>th</sup> May 2018 to 30<sup>th</sup> May 2018.**

Any claim for inclusion of a new name, if registered & still borne within the appointed date i.e. **31<sup>st</sup> January, 2018** but not appearing in the Draft Electoral Roll, or any objection to any entry in the Draft Electoral Roll, shall be made in the form prescribed in the Election Rules, namely Form II(a) or Form II(b) or Form II(c) as the case may be (copies of which will be had on application from the office of the Returning Officer). Such claim or objection shall be filed within the said period namely **from 7<sup>th</sup> May 2018 to 30<sup>th</sup> May 2018** and will be examined and decided by the Returning Officer and his decision will be final under rule 5(3) of the Election Rules.

The Draft Electoral Roll will be corrected in accordance with the decision of the Returning Officer and the roll thus corrected shall be the Final Electoral Roll for the election. In the preparation of the Final Electoral Roll, registration and restoration after the afore-mentioned appointed date namely, the **31<sup>st</sup> January, 2018** or new qualifications or employment obtained after that date will be disregarded and no person whose name is not included in the Final Electoral Roll for the election, shall be entitled to participate in the election. Changes of address after the Final Electoral Roll has been prepared will be disregarded [Rule 5(4) of the Election Rules].
